**Important Notice:
Dealing Suspension of Certain Investment Choices under
Manulife Investment Solutions (“MISo”), Manulife Investment Plus (“MI Plus”), Manulife Wealth Creator (“MWC”), Alpha,
Alpha Regular Investor (“ARI”), Matrix and ManuSelect Investment Protector (“MIP”)**

Due to the closure of the stock exchange in Turkey and some stock exchanges in the Middle East and North Africa region for the religious and national holidays, the relevant underlying funds will have no valuation to provide and the valuation and dealing of the following corresponding investment choices will be suspended. The suspension periods and dates of resumption of valuation and dealing for each of the investment choices are set out as follows:
