**Changes to Investment Principles and Restrictions and Other Amendments of the Prospectus  
of the Underlying Funds**

We would like to notify you of the following changes with regard to the following underlying funds (each an “**Underlying Fund**” and collectively, the “**Underlying Funds**”) corresponding to the following investment choices under the Plans, following our receipt of the shareholder notice of the Underlying Funds dated February 26, 2018 (the “**Shareholder Notice**”).

We were informed that the following changes will become effective on March 29, 2018, unless otherwise specified.

**1. Changes to Investment Principles and Restrictions**

*a) Changes of Investment Restrictions of Allianz Income and Growth and Allianz Hong Kong Equity*

The above Underlying Funds are currently subject to Taiwan Restriction (see Appendix I to the Shareholder Notice for the definition), which includes, inter alia, the restriction that the total amount invested directly in China A-Shares shall not exceed 10% of its net asset value (“**NAV**”), or such other percentage as may be stipulated by the Taiwan Financial Supervisory Commission (“**FSC**”) from time to time.

To comply with the applicable legal and regulatory requirements in Taiwan, with effect from January 8, 2018, the above restriction under the Taiwan Restriction also applies to investment in China Interbank Bond Markets such that the total amount invested directly in China A-Shares and China Interbank Bond Markets shall not exceed 10% of its NAV, or such other percentage as may be stipulated by the FSC from time to time.

For the avoidance of doubt, the asset class principles of these Underlying Funds remain unchanged.

*b) Removal of Investment Principle of the Underlying Funds*

To comply with the applicable legal and regulatory requirements in Germany in respect of the Germany Investment Tax Act as amended and effective as of January 1, 2018, with effect from January 8, 2018, the investment principle letter j) under the sub-section headed “**3. In investing the assets of the Company, the following restrictions must be observed:**” under the section headed “**Part A: General Investment Principles applicable to all Sub-Funds**” of Appendix 1 of the Prospectus of the Underlying Funds (the “**Prospectus**”) (see Appendix I to the Shareholder Notice for details) has been removed.

For the avoidance of doubt, there are no changes to the operation and/or manner in which the Underlying Funds are being managed as a result of the above change.

## **2. Other Amendments**

In addition to the changes set out above, the Prospectus will be amended to reflect the following:

- a) with effect from January 1, 2018, the entity which performs the subsequent monitoring of investment limits and restrictions of the Underlying Funds has been changed from State Street Bank Luxembourg S.C.A. to Allianz Global Investors GmbH;
- b) with effect from the trading deadline of April 27, 2018, the entity which acts as Registrar and Transfer Agent of the Underlying Funds will be changed from RBC Investor Services Bank S.A. to State Street Bank Luxembourg S.C.A.;
- c) update on the commission sharing arrangements of the management company of the Underlying Funds;
- d) update on the remuneration policy of the management company of the Underlying Funds;
- e) update on the risk factor “Risks of Using Stock Connect”; and
- f) update on information relating to securities repurchase agreements and securities lending transactions.

Please refer to the Shareholder Notice for the remaining amendments to the Prospectus.

The Hong Kong offering documents of the Underlying Funds will be updated to reflect the above changes. Please refer to the latest offering documents and Shareholder Notice of the Underlying Funds for further information of the above and other changes to the Underlying Funds.
