1. Amendment of Enhanced Disclosure / Elaboration of Investment Policy of PARVEST Bond Asia ex-Japan and PARVEST Bond Best Selection World Emerging

According to the shareholder notice of PARVEST Bond Asia ex-Japan and PARVEST Bond Best Selection World Emerging dated April 24, 2018, following the regular review of the Underlying Funds to ensure they remain relevant for investors as investment markets evolve, the enhanced disclosure / elaboration of investment policy of the Underlying Funds will be amended as shown in the appendix to the said shareholder notice with immediate effect.

The changes will not result in any increase in fees or charges to be borne by the shareholders of the Underlying Funds or the Underlying Funds. Also, such changes will not materially prejudice the rights of interest of the existing investors of the Underlying Funds.

2. Change of Administrator, Company Secretary and Depository of PIMCO Global High Yield Bond Fund and PIMCO Income Fund

According to the shareholder notice of PIMCO Global High Yield Bond Fund and PIMCO Income Fund dated April 30, 2018, the Hong Kong offering documents of the Underlying Funds will be updated, to reflect, amongst other amendments, the following changes made to the prospectus of the Underlying Funds dated July 3, 2017:

- (a) The change of the administrator and company secretary from Brown Brothers Harriman Fund Administration Services (Ireland) Limited to State Street Fund Services (Ireland) Limited (effective from July 1, 2017); and
- (b) The change of the depository from Brown Brothers Harriman Trustee Services (Ireland) Limited to State Street Custodial Services (Ireland) Limited (effective from July 1, 2017).

The Hong Kong offering document of the respective Underlying Funds will be updated to reflect the changes above. Please refer to the respective shareholder notices and the offering documents of the Underlying Funds for further information relating to the above and other changes.
