**Important Notice:
Dealing Suspension of Certain Investment Choices under
Manulife Investment Plus (“MI Plus”), Manulife Investment Solutions (“MISo”), Manulife Wealth Creator (“MWC”), Alpha,
Alpha Regular Investor (“ARI”), Matrix and ManuSelect Investment Protector (“MIP”)**

Due to the closure of the stock exchange in Turkey and some stock exchanges in the Middle East and North Africa region for the religious and national holidays, the underlying funds of the following investment choices will have no valuation to provide and the valuation and dealing of the following investment choices will be suspended accordingly. The suspension periods and dates of resumption of valuation and dealing for each of the investment choices are set out as follows:
