**Important Notice:  
Dealing Suspension of Certain Investment Choice(s) under  
Manulife Investment Plus (“MI Plus”), Manulife Investment Solutions (“MISo”),  
Manulife Wealth Creator (“MWC”), Alpha, Alpha Regular Investor (“ARI”) and Matrix  
(each a “Plan” and collectively, the “Plans”)**

Reference is made to our policyowners notice of the Plans dated May 30, 2018 and the respective shareholder notices of Invesco Funds Series 2 – Invesco Emerging Markets Bond Fund, Invesco Funds Series 2 – Invesco Global High Income Fund and Invesco Funds Series - Invesco Japanese Equity Core Fund (each an “Underlying Fund” and collectively, the “Underlying Funds”) dated April 23, 2018 (the “Shareholder Notices”) regarding the proposed merger of the Underlying Funds into Invesco Funds - Invesco Emerging Markets Bond Fund, Invesco Funds - Invesco Global High Income Fund and Invesco Funds - Invesco Japanese Equity Core Fund respectively. As informed by the Underlying Funds recently, an extraordinary general meeting (“EGM”) of shareholders of the Underlying Funds was held on August 13, 2018 as per the terms set out in the Shareholder Notices. As the requisite quorum was not reached for the Underlying Funds on August 13, 2018, an adjourned EGM of the Underlying Funds was held on August 29, 2018, for which no quorum was required. The resolution to consider the proposed merger was approved by requisite majority. As a result, the merger will take effect on October 5, 2018.

According to the Shareholder Notices, from October 3, 2018 to October 5, 2018, both dates inclusive, any dealings in the Underlying Funds will be suspended temporarily so as to allow the merger process to be effected efficiently. In view of such, the valuation and dealing of the corresponding investment choices (the “Investment Choices”) will be suspended accordingly. The suspension period and date of resumption of valuation and dealing for the Investment Choices are set out as follows:

Pursuant to the relevant Principal Brochures relating to the Investment Choices, Manulife (International) Limited (Incorporated in Bermuda with limited liability) (the “Company”) may suspend dealing and determination of the net asset value of an investment choice in the circumstances of (i) there is in existence any state of affairs prohibiting the normal disposal of the underlying investments or assets of the investment choice; and/or (ii) in the opinion of the Company, acting in good faith and commercially reasonable manner, it is not practicable or is prejudicial to the interest of the policyowners to realize any underlying investments or assets of the investment choice.

All instructions in respect of subscription, redemption and switching of units of the Investment Choices received by the Company during the suspension period (see the above table) will be processed after the resumption of valuation and dealing. During the suspension, policyowners may withdraw or change his/her instructions in respect of any subscription, redemption or switching of units of the Investment Choices.
