**Important Notice:  
Dealing Suspension of Certain Investment Choice(s) under  
Manulife Investment Plus (“MI Plus”) and Manulife Investment Solutions (“MISo”)**

Due to the closure of the stock exchange in Luxembourg for the official holidays, the relevant underlying funds of the following investment choices (collectively, the “**Underlying Funds**”) will have no valuation to provide. Such dates are the days following the respective record dates of the Underlying Funds in May 2019. And therefore, the prices of the corresponding investment choices (collectively, the “**Investment Choices**”) cannot be ascertained on such dates. In view of such, the valuation and dealing of the Investment Choices will be suspended accordingly. The suspension dates and dates of resumption of valuation and dealing for each of the Investment Choices are set out as follows:

Pursuant to the relevant Principal Brochures relating to the Investment Choices, Manulife (International) Limited (Incorporated in Bermuda with limited liability) (the “**Company**”) may suspend dealing and determination of the net asset value of an investment choice in the circumstances that (i) there is a closure of, or suspension or restriction of trading on any securities markets on which a substantial part of the underlying investments or assets of the relevant investment choice is traded; and/or (ii) for any other reason, the prices of the underlying investments or assets of an investment choice cannot, in the opinion of the Company, acting in good faith and commercially reasonable manner, be ascertained.

All instructions in respect of subscription, redemption and switching of units of the Investment Choices received by the Company on the suspension dates (see the above table) will be processed after the resumption of valuation and dealing. During the suspension, policyowners may withdraw or change his/her instructions in respect of any subscription, redemption or switching of units of the Investment Choices.
