**Important Notice:  
Dealing Suspension of Certain Investment Choice(s) under  
Manulife Investment Plus (“MI Plus”), Manulife Investment Solutions (“MISo”), Manulife Wealth Creator  
 (“MWC”), Alpha, Alpha Regular Investor (“ARI”), Matrix and ManuSelect Investment Protector (“MIP”)**

Due to the closure of the stock exchange in Turkey and some stock exchanges in the Middle East and North Africa region for religious and national holidays, the relevant underlying funds will have no valuation to provide and the valuation and dealing of the corresponding investment choices (collectively, the “**Investment Choices**”) will be suspended. The suspension periods and dates of resumption of valuation and dealing for each of the Investment Choices are set out as follows:
