**Important Notice:
Dealing Suspension of Certain Investment Choice(s) under
Manulife Investment Plus (“MI Plus”), Manulife Investment Solutions (“MISo”), Manulife Wealth Creator
 (“MWC”), Alpha, Alpha Regular Investor (“ARI”), and Matrix**

Due to the closure of the stock exchange in China, Taiwan and the United States of America for public holidays respectively, the relevant underlying funds will have no valuation to provide and the valuation and dealing of the corresponding investment choices (collectively, the “**Investment Choices**”) will be suspended. The suspension periods and dates of resumption of valuation and dealing for each of the Investment Choices are set out as follows:
