With effect from February 10, 2020, the disclosures in relation to the benchmark in the section entitled “Additional Information” of each Underlying Fund in its offering document (the “**Offering Document**”) has been updated.

The update is in response to the revised Q&A released by the European Securities and Markets Authority (“**ESMA**”) in March 2019 on the application of the UCITS Directive, which clarifies benchmark and past performance disclosure obligations for UCITS. As a result, the disclosures in relation to the benchmark under the section entitled “Additional information” of each Underlying Fund in the Offering Document has been enhanced to provide greater transparency on the degree to which the Underlying Funds may resemble its benchmark.
