**Important Notice:
Dealing Suspension of Certain Investment Choice(s) under
Manulife Investment Plus (“MI Plus”), Manulife Investment Solutions (“MISo”),
Alpha, Alpha Regular Investor (“ARI”), and Matrix**

Due to the closure of the stock exchange in Mainland China for public holidays, the relevant underlying funds will have no valuation to provide and the valuation and dealing of the corresponding investment choices (collectively, the “**Investment Choices**”) will be suspended. The suspension period and date of resumption of valuation and dealing for each of the Investment Choices are set out as follows:

During the suspension, policyowners may withdraw or change his/her instructions in respect of any subscription, redemption or switching of units of the Investment Choices.
