**Important Notice:  
Suspension of Valuation of Certain Investment Choice(s) under  
Manulife Investment Plus (“MI Plus”), Manulife Investment Solutions (“MISo”),  
Alpha, Alpha Regular Investor (“ARI”) and Matrix**

Due to the upcoming merger of the following underlying funds (each an “**Underlying Fund**” and collectively, the “**Underlying Funds**”) on March 29, 2021 (the “**Merger Date**”)\*, the liquidation of the Underlying Funds’ portfolio will commenced at approximately four business days prior to the Merger Date. During the liquidation, the Underlying Funds may not always be able to adhere to their respective investment policies. In view of such, the valuation of the investment choices corresponding to the Underlying Funds (each an “**Investment Choice**” and collectively, the “**Investment Choices**”) will be suspended. The suspension period and date of resumption of valuation for the Investment Choices are set out in the following table.

Please also note that we have ceased to allow new applications for regular subscription and top-up subscription of the Investment Choices, as well as new applications for switching into the Investment Choices.
