Due to the closure of stock exchanges in Mainland China, Taiwan and the United States for the Lunar New Year / national holiday respectively, the relevant underlying funds will have no valuation to provide and the valuation and dealing of the following corresponding investment choices (collectively, the “**Investment Choices**”) will be suspended. The suspension period and date of resumption of valuation and dealing for the respective Investment Choices are set out as follows:
