Creator (“MWC”) / Alpha / Alpha Regular Investor (“ARI”) / Matrix**

Due to the closure of the stock exchanges in Korea, Taiwan and Mainland China for the public holidays, the relevant underlying funds will have no valuation to provide and the valuation and dealing of the following corresponding investment choices (collectively, the “**Investment Choices**”) will be suspended. The suspension period and date of resumption of valuation and dealing for the respective Investment Choices are set out as follows:
