Close to New / Regular Subscription and Switch-in to the Investment Choices

We would like to notify you of the closure of the following investment choices under the Plans (each an “**Investment Choice**” and collectively, the “**Investment Choices**”), following the notification from the corresponding underlying fund (the “**Underlying Fund**”).

As informed by the Underlying Fund, the Underlying Fund will cease marketing to new investors and begin to control further inflows with effect from March 9, 2020. As a result, we decided to cease to allow new subscriptions (whether by way of lump-sum subscription or regular subscription) and switch-in to the Investment Choices with effect from March 9, 2020 (the “Effective Date”).

Your Action

(i) For existing holding of notional units of the Investment Choice(s)

If you have holding of notional units in the Investment Choice(s), there will be no impact on your existing holding of the notional units of such Investment Choice(s) and you can continue to switch out/redeem from the Investment Choice(s) after the Effective Date.

(ii) For existing regular subscription to the Investment Choice(s)

If you have arranged regular subscription to the Investment Choice(s), you may change such regular subscription allocation instruction to any other investment choice(s) that is/are open for subscription under the respective Plans free of charge, by sending a completed and signed prescribed form to our Administration Office before 3:00pm on March 27, 2020 to update your regular subscription allocation instruction. After which, if we do not receive your instruction, we will change your existing regular subscription allocation instruction in respect of such Investment Choice(s) to the applicable Default Investment Choice(s) (see details below) free of charge on March 30, 2020.
