# How can you cope with medical inflation?

Amid rising prices for goods and services over the years, medical services have recorded significant price hikes. In 2019, the average cost of health care is estimated to climb by 8.3% in Hong Kong and 8.6% in Asia<sup>1</sup>.

Advances in medical technology, including the development of minimally-invasive surgery and new drugs, are broadening the range of illnesses that can be treated and cured – but the cost is usually higher. As Hong Kong's aging population translates to an inevitable rise in demand for medical services, the resulting pressure on both public and private hospitals will drive medical costs even higher.

# Facts you should know

While public hospitals offer more affordable rates, there are long waiting lists for treatment. For those who opt for private hospitals, the cost will be much higher. Worse still, most of these costs will continue to rise year after year.
