Important Information

Investment Objectives

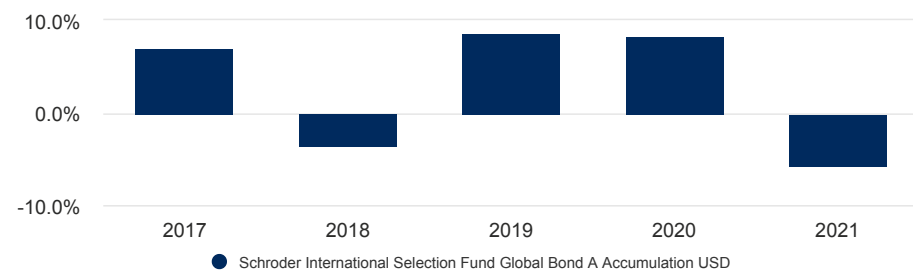

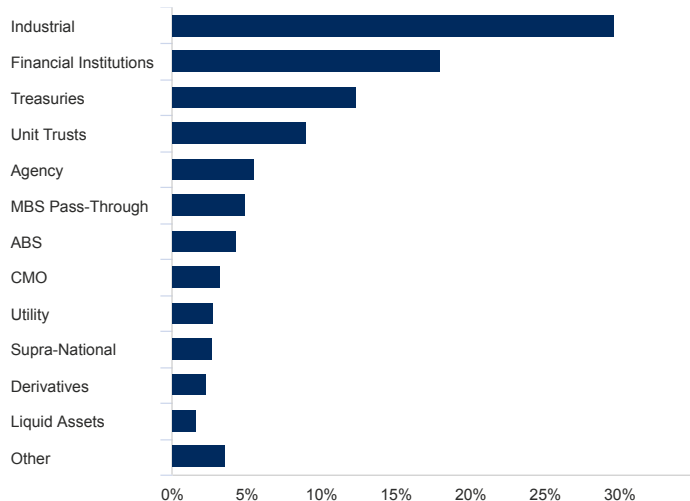

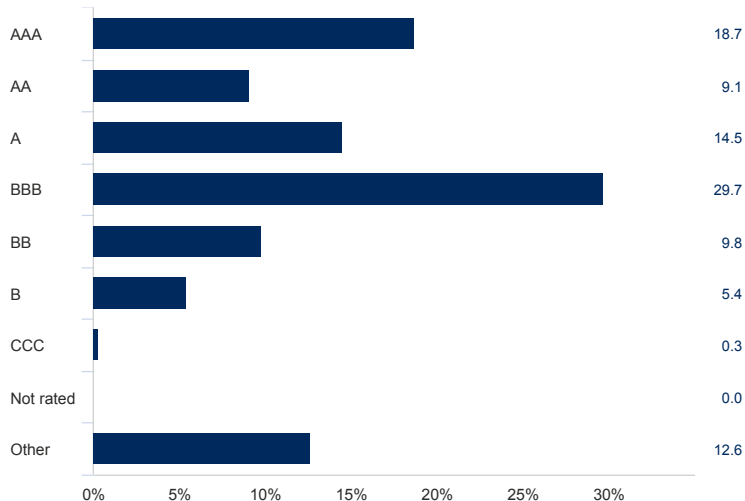

Sector (%)



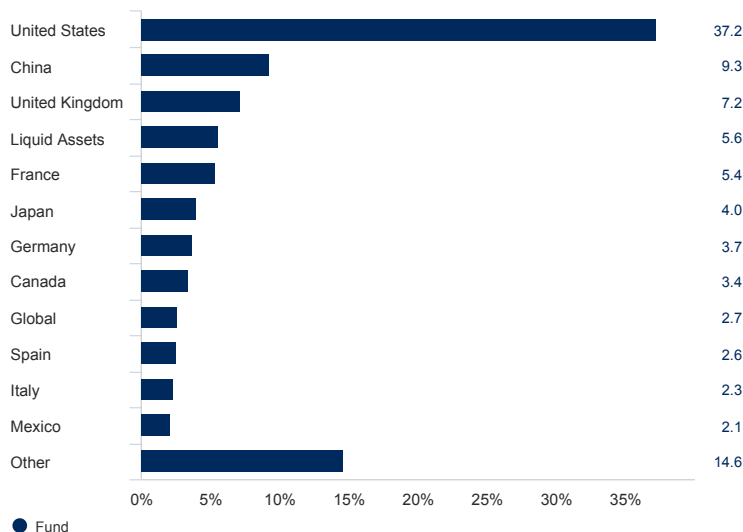

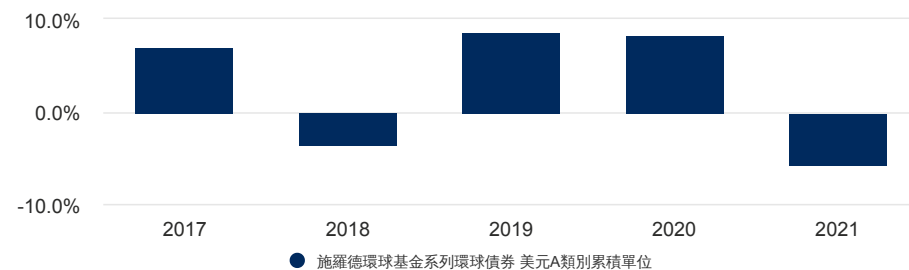

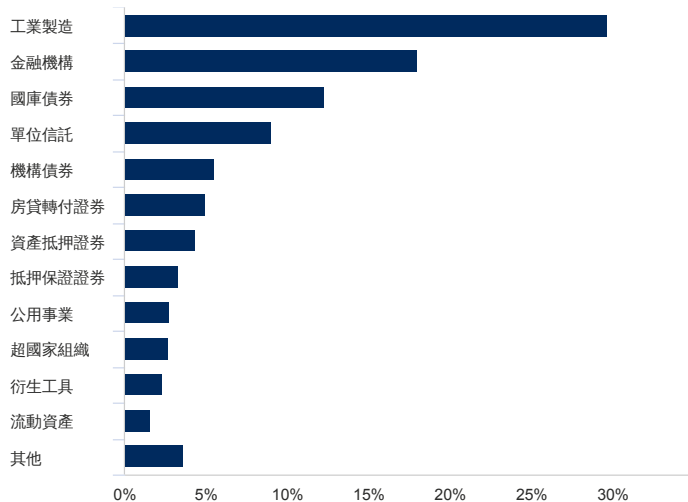

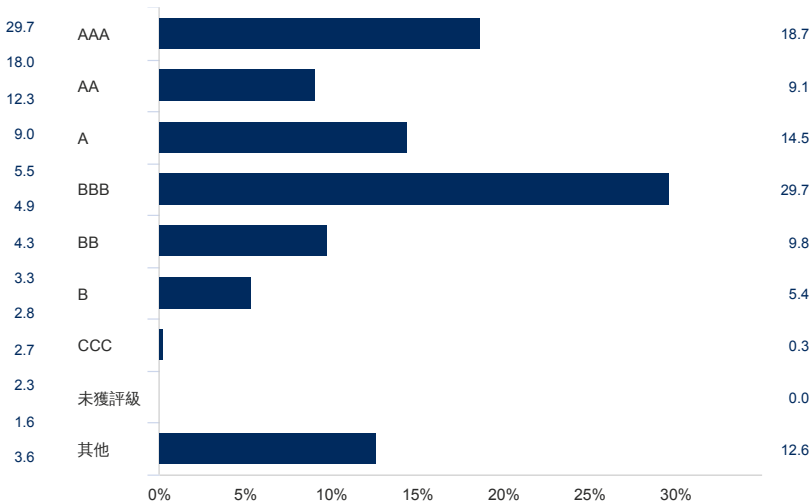

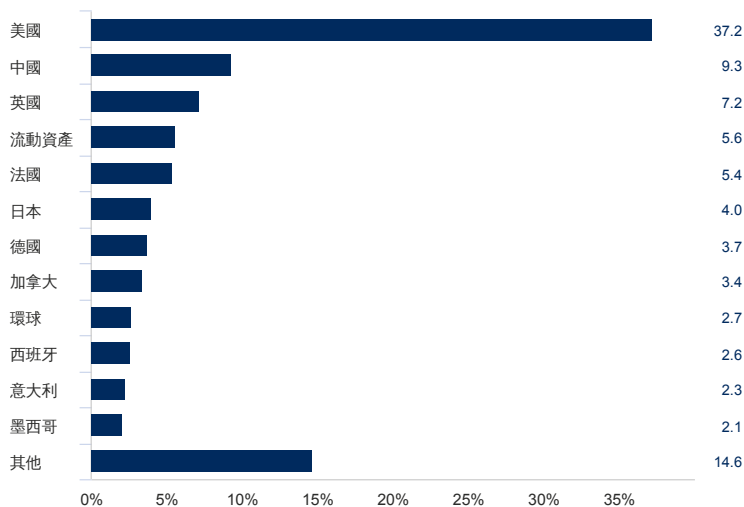
