

Important Information

The fund invests primarily in equity and equity related securities of Asian (ex Japan) companies.

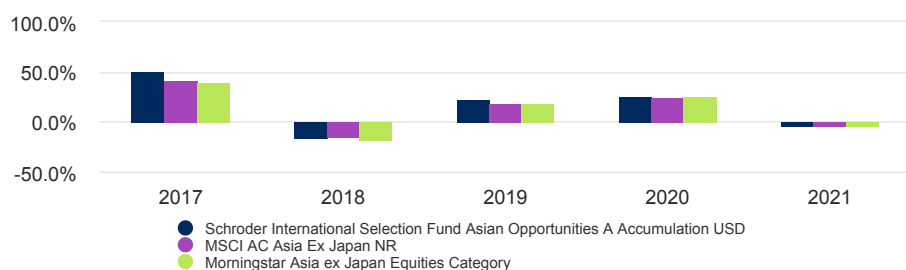

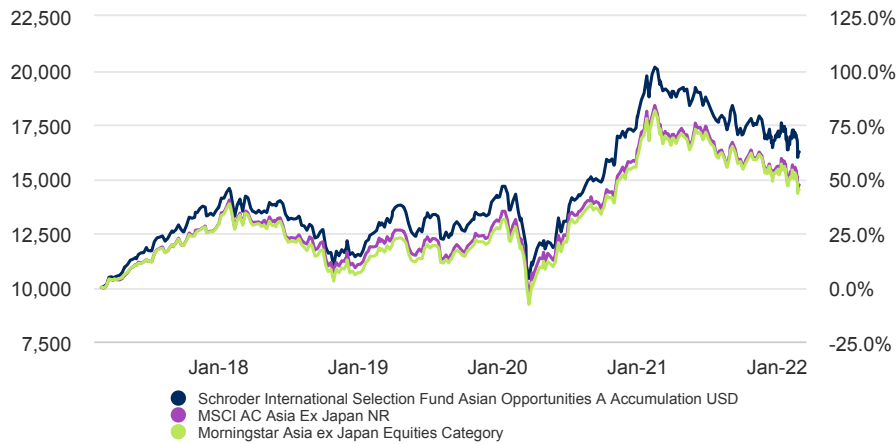

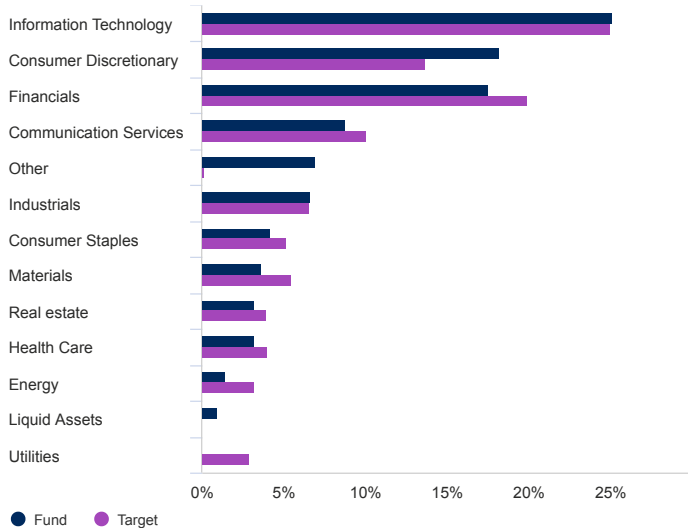

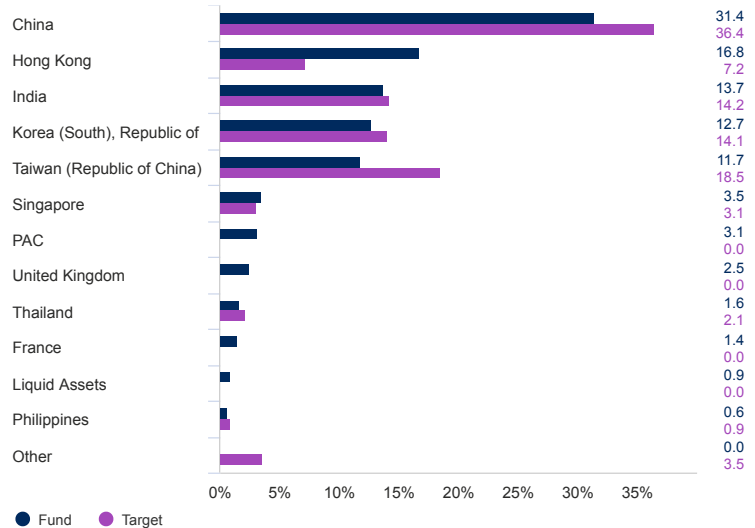

Sector (%)



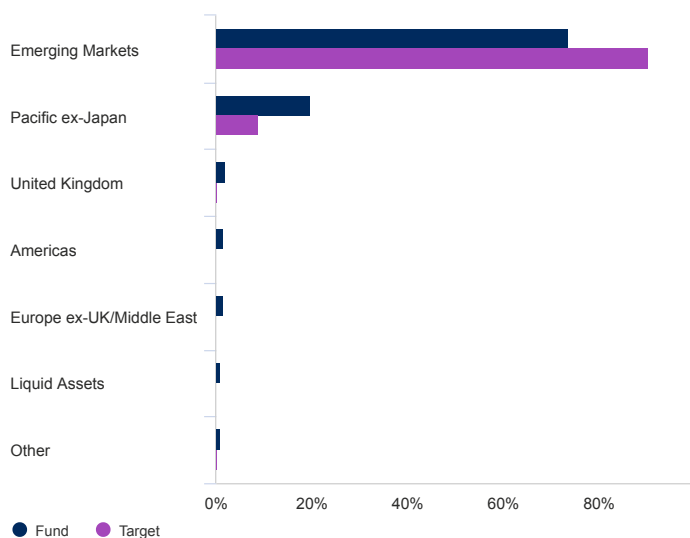
Geographical Breakdown (%)

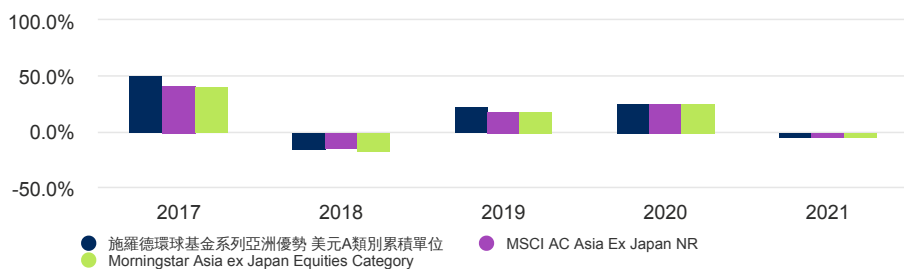

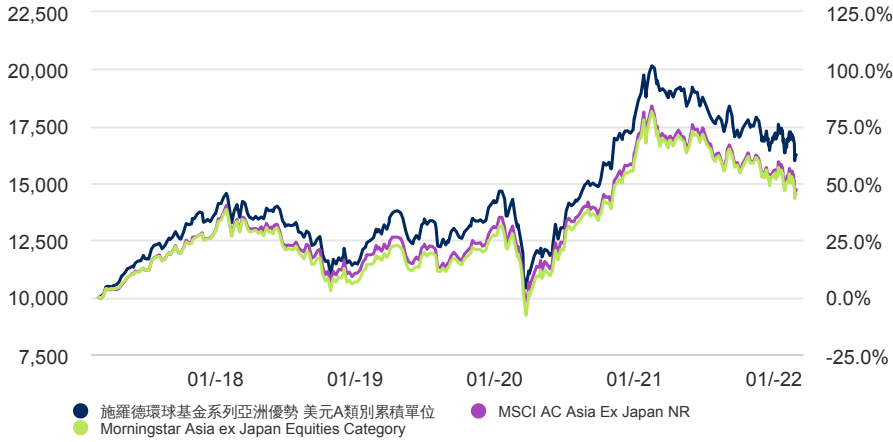

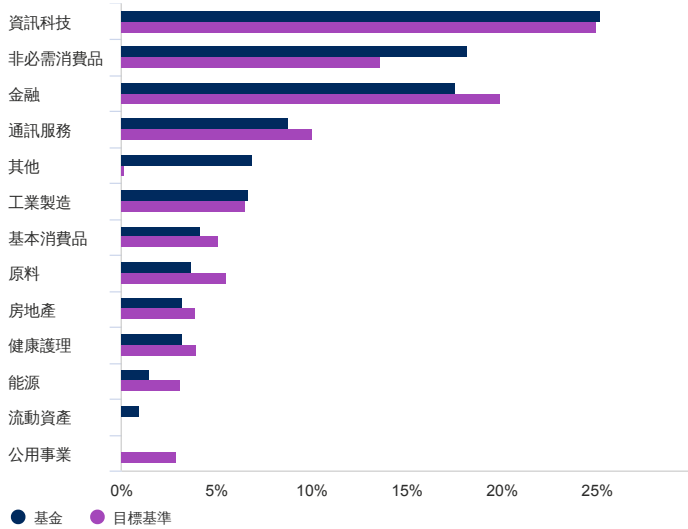

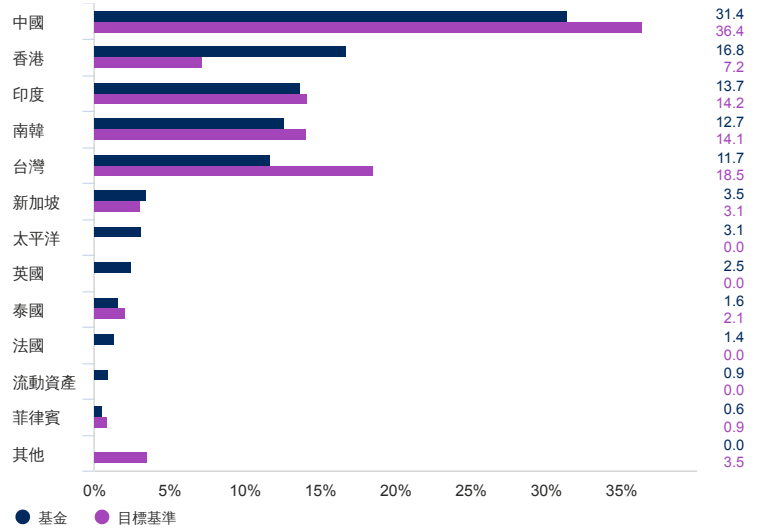

地區資產分佈 (%)



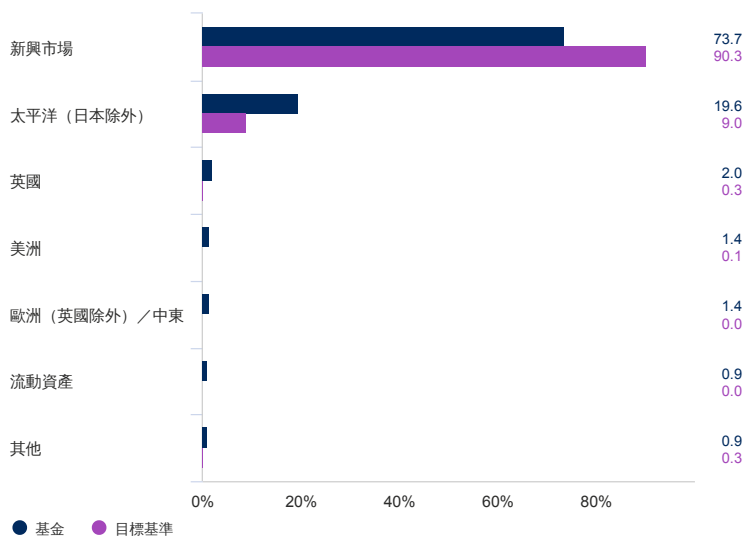
