

Important Information

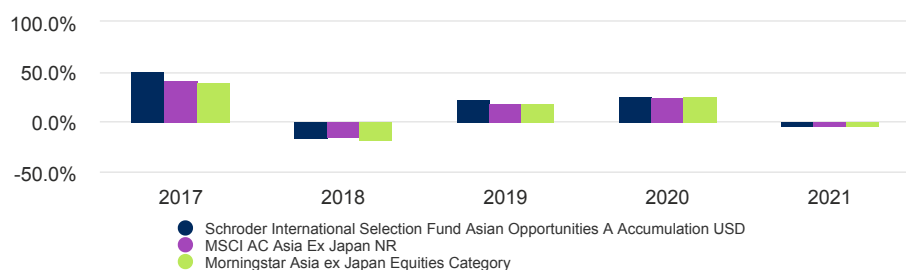

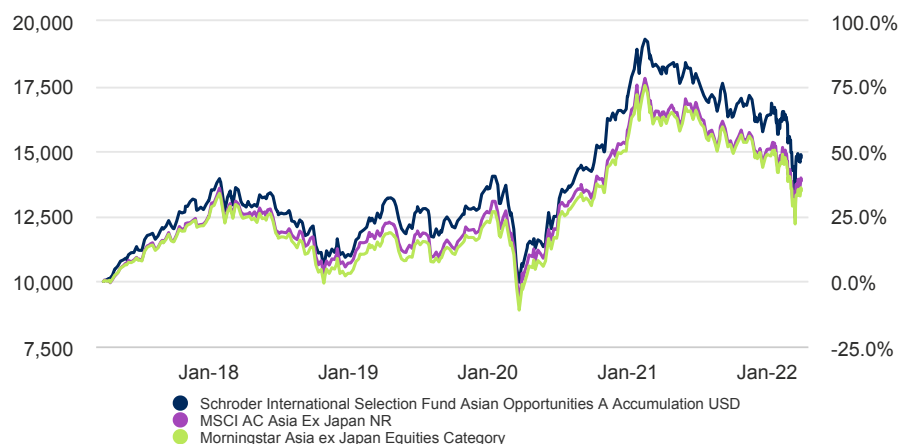

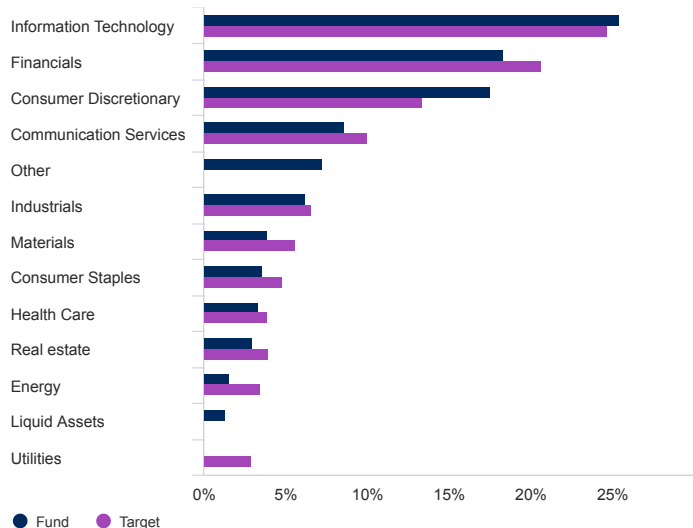

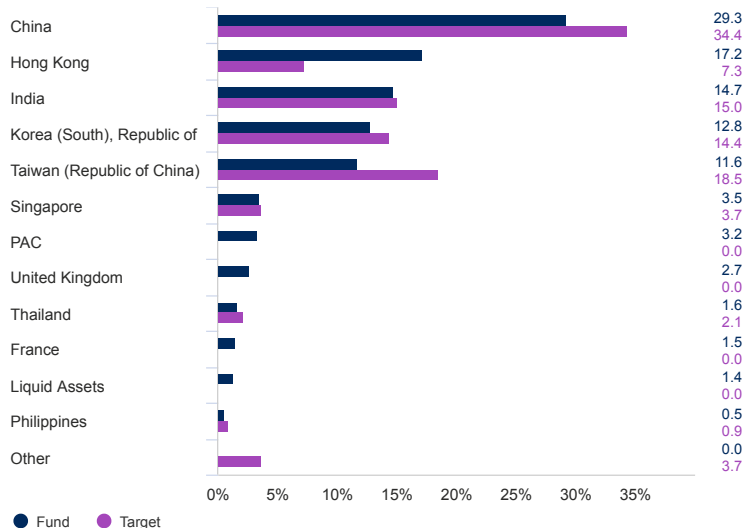

Sector (%)



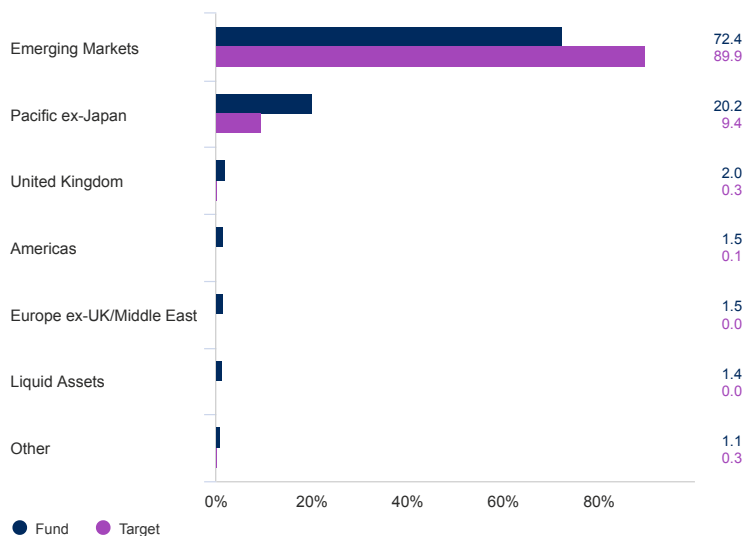
Geographical Breakdown (%)

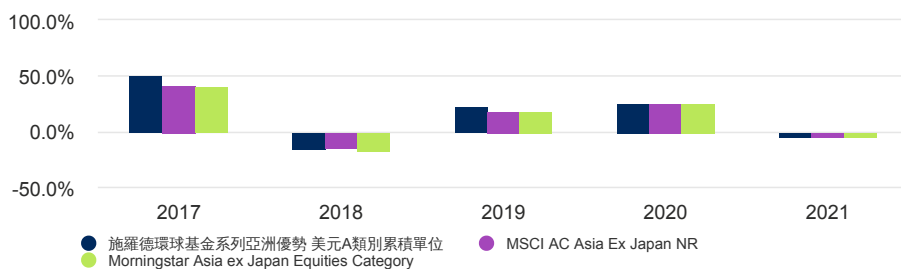

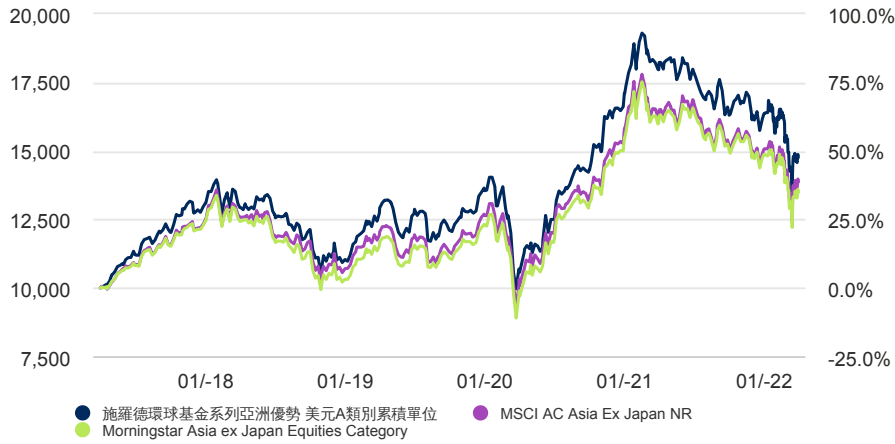

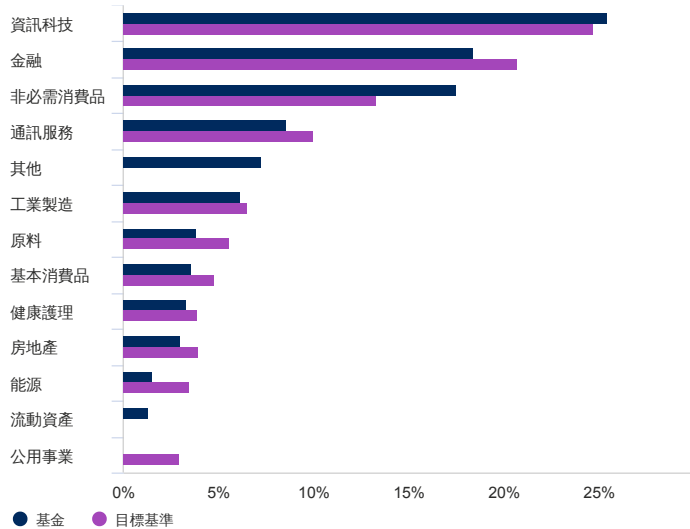

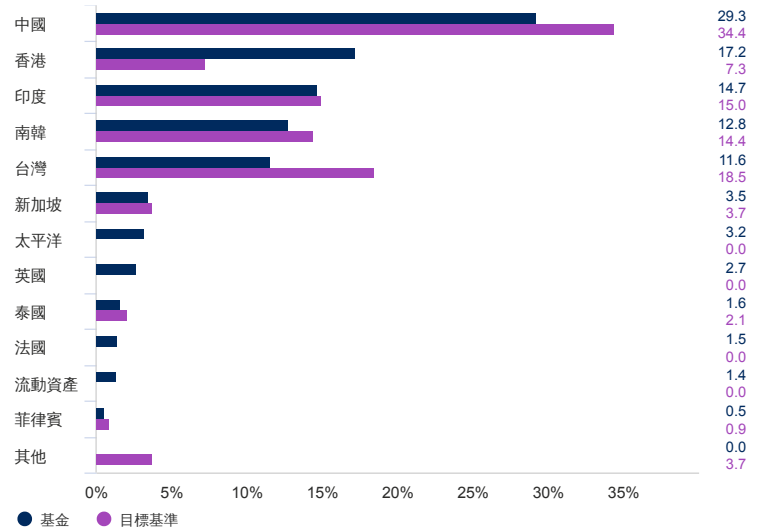

行業資產分佈 (%)

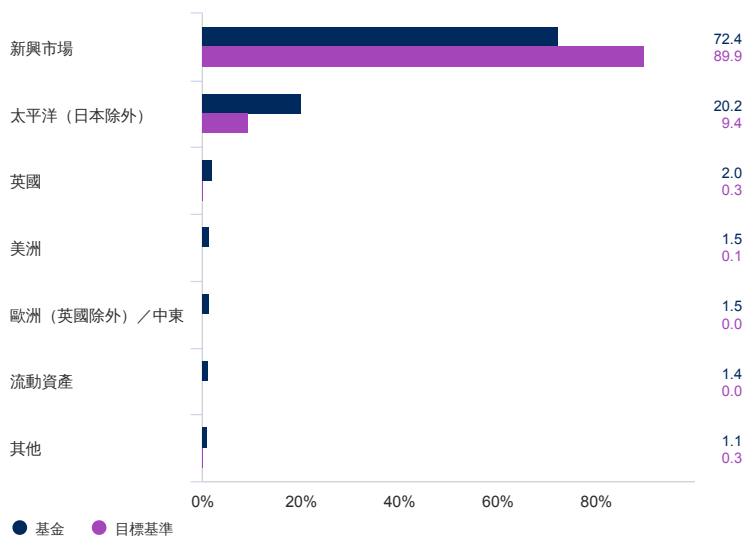


地區資產分佈 (%)
