

### Important Information

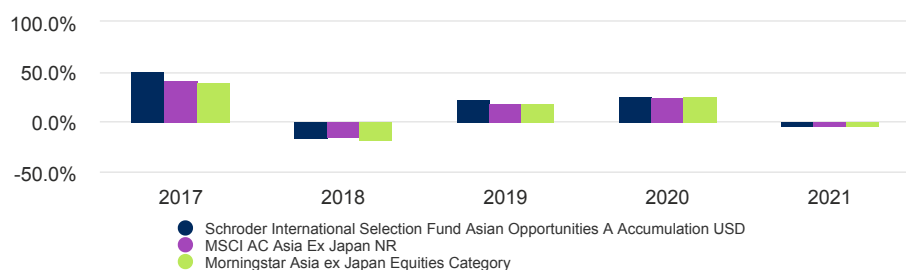

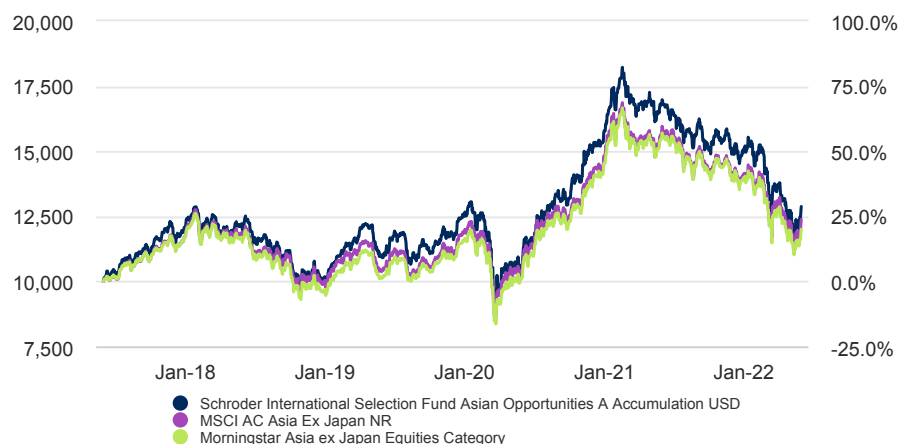

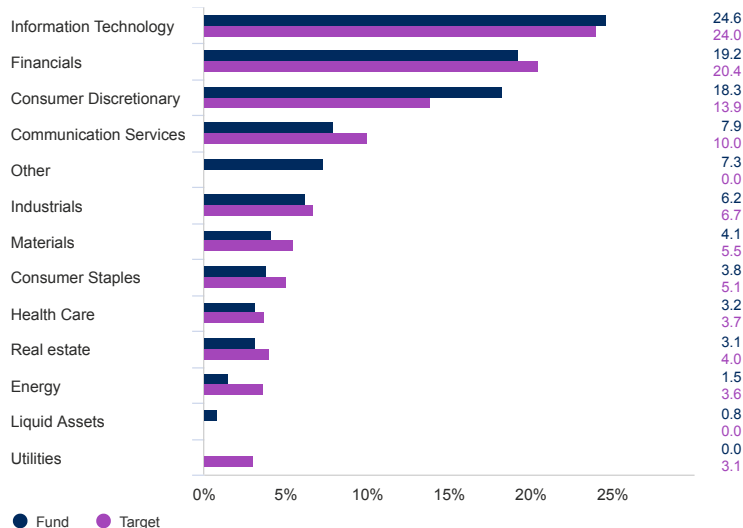

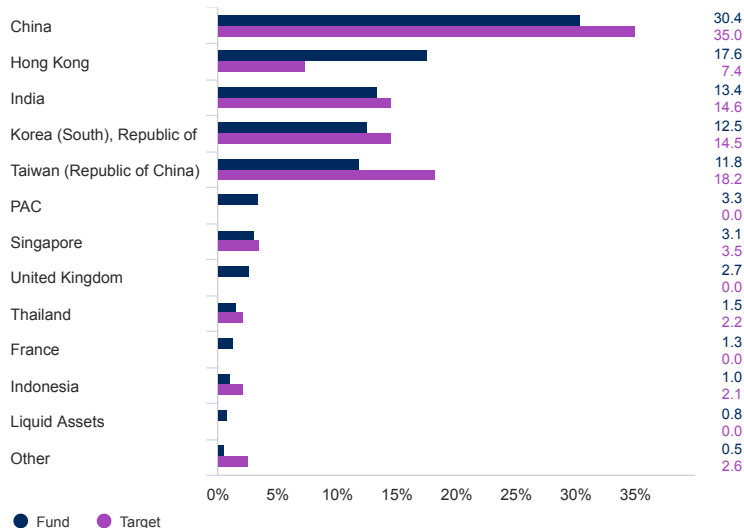

### Sector (%)



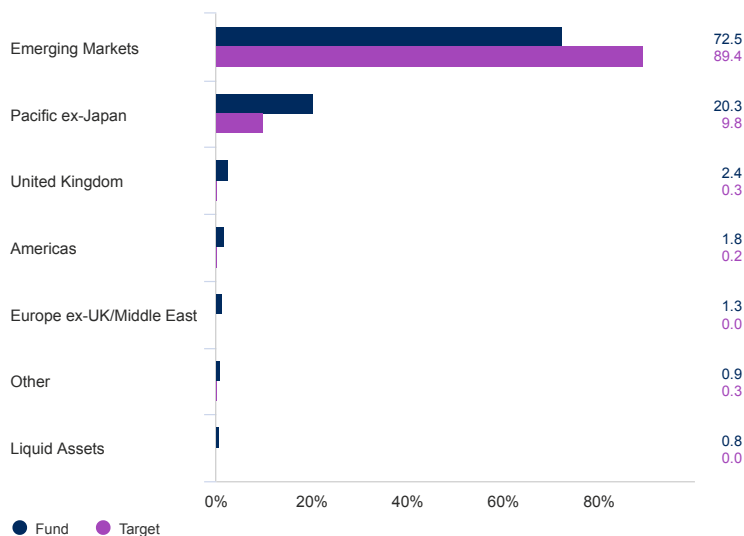
### Geographical breakdown (%)

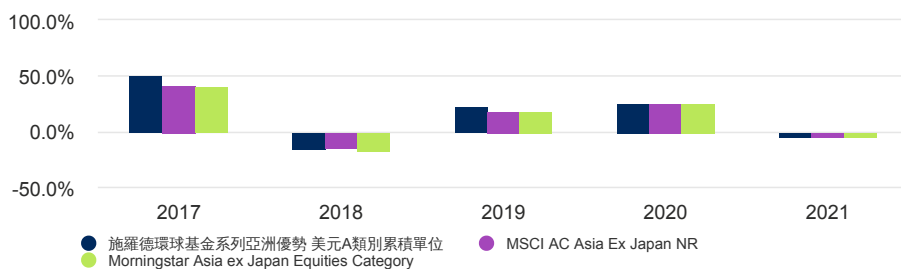

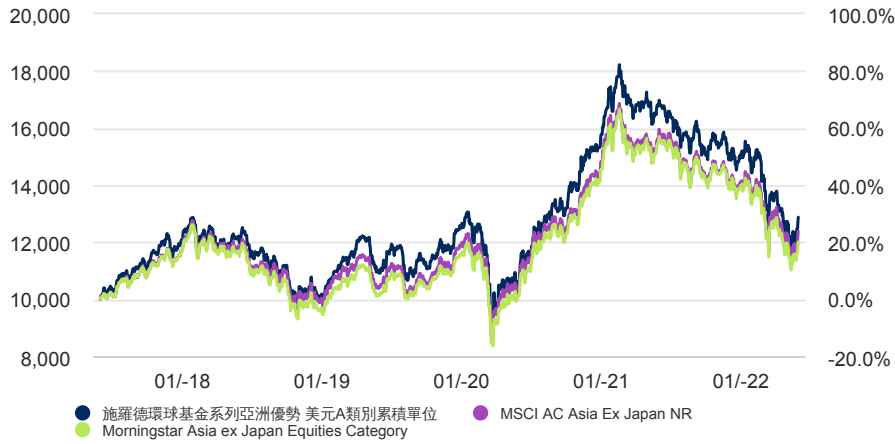

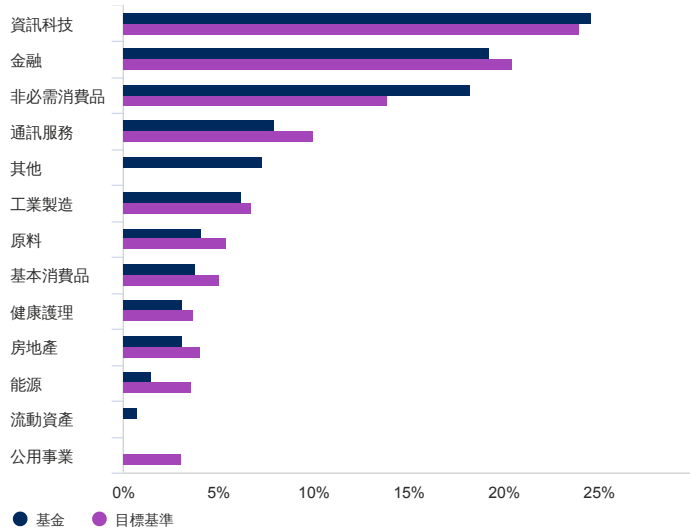

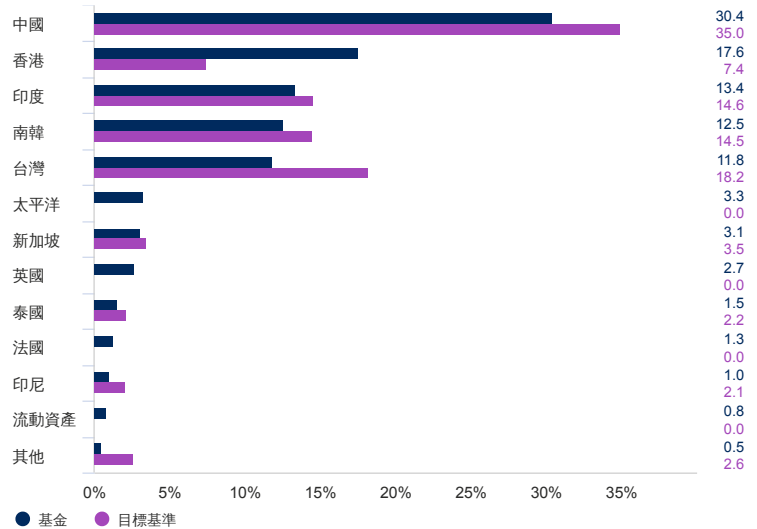

#### 地區資產分佈 (%)



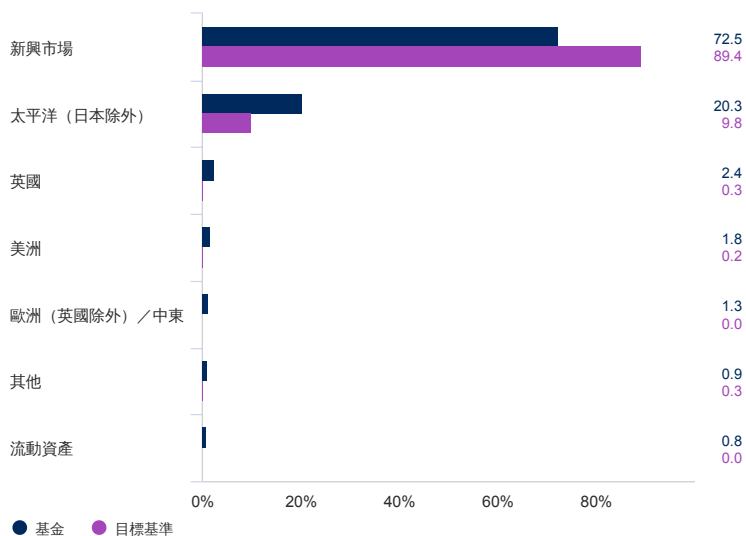
