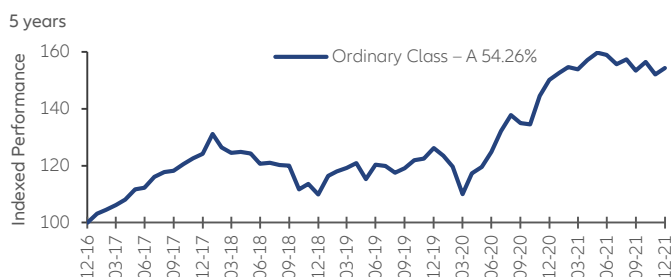

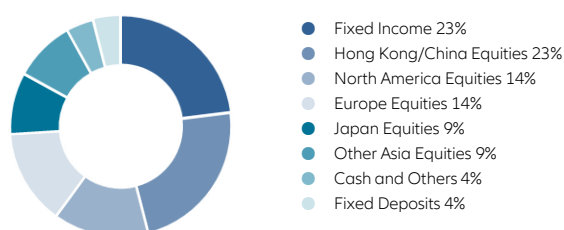

Manager's Comments

It was a volatile month for US equities. Stocks whipsawed as investors reacted to the prospect of tighter US monetary policy and weighed up the impact of the highly contagious Omicron variant on economic recovery. In addition, US growth prospects were dealt a blow by doubts that President Joe Biden's flagship Build Back Better bill would be unable to garner sufficient support in its current form.

US bonds sold off in December, with the yield curve flattening in response to the Federal Reserve's pivot to a more hawkish stance. Yields on shorter dated maturities rose, with the yield on the two-year note moving to its highest level since the start of the pandemic. In contrast, whilst longer dated bond yields initially moved lower, they rose once more as fears over the Omicron variant eased. US corporate bonds outperformed Treasuries as credit spreads narrowed.

基金經理評論

美國股市在月內反覆波動。由於投資者對美國可能收緊貨幣政策的前景作出反應，並權衡具有高度傳染性的Omicron變種病毒對經濟復甦的影響，導致股市大幅下挫。此外，由於市場懷疑總統喬·拜登（Joe Biden）的旗艦級重建美好未來計劃（Build Back Better）法案在目前的形勢下無法獲得足夠的支持，美國增長前景受到打擊。

美國債券在12月份被拋售，收益率曲線趨於平坦，主要受美國聯儲局轉向採取更鷹派立場的影響。較短期債券的收益率上升，兩年期國庫券收益率升至疫情爆發以來的最高水平。相比之下，雖然較長期債券的收益率在月初下跌，但隨著對Omicron病毒變種的擔憂緩和，它們再次上升。由於信貸息差收窄，美國企業債券表現優於國庫券。
