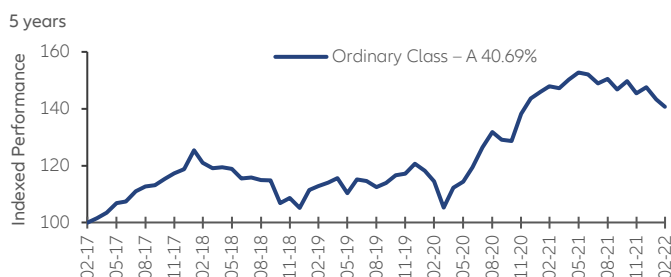

### Manager's Comments

US equities sold off in February, with volatility remaining elevated. The S&P 500 Index touched its lowest level since June 2021, as sentiment was hurt by fears that the Federal Reserve (Fed) would be more aggressive in raising interest rates and news that Russia had invaded Ukraine. When added to US equity losses in January, the sell-off took the S&P 500 Index into correction territory, defined as a decline of 10% from a recent peak. US bonds sold off in February amid speculation that the Federal Reserve would need to be more aggressive in raising rates to tackle rampant inflation. While news that Russia had invaded Ukraine provided some support for US bonds, as investors sought safe havens, yields still closed the month higher and the yield curve continued to flatten.

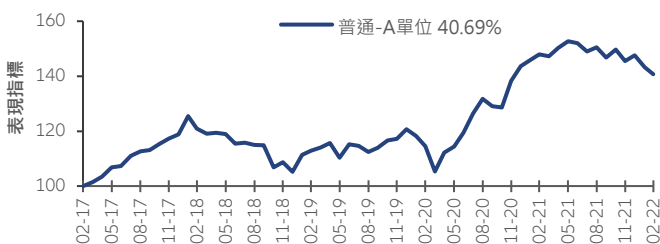

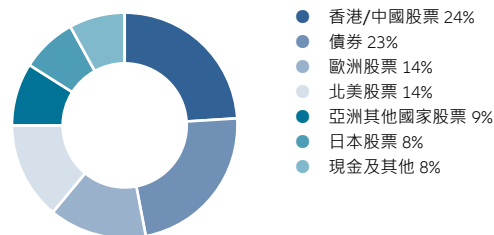

## 基金經理評論

美國股市在2月份被拋售，波動性仍然很高。標準普爾500指數觸及2021年6月以來的最低水平，因為市場擔心美國聯儲局可能採取更積極的加息步伐，加上俄羅斯入侵烏克蘭的消息，均利淡市場情緒。加上美國股市在1月份的損失，拋售潮令標準普爾500指數進入調整區域，即較近期高位下跌10%。美國債券在2月份被拋售，因為市場揣測美國聯儲局將需要更積極地加息，以應對急劇的通脹。雖然由於投資者尋求避險資產，俄羅斯入侵烏克蘭的消息為美國債券帶來一定支持，但收益率仍然在月內收高，收益率曲線持續趨於平坦。
