Manager's Comments

US equities rallied overall. News that California-based start-up lender SVB Financial had collapsed rocked the market, coming just days after the failure of cryptocurrency-focused Signature Bank. The news sparked a flight out of smaller lenders, causing a group of well capitalised larger banks, such as JPMorgan Chase and Bank of America, to deposit USD 30 billion to prop up troubled lender First Republic Bank, US bonds closed a volatile month with positive returns. An initial sell-off at the start of March saw the 10-year Treasury bond trade back above 4.0% whilst the yield on the two-year note rose above 5.0 % for the first time since 2007. The resultant yield curve inversion of more than 100 basis points (bps) was the most extreme since 1981



基金經理評論

美國股市整體上升。專注於加密貨幣業務的簽名銀行(Signature Bank),以及在加州專為初創公司貸款的矽谷銀行(SVB Financial)在數天內相繼倒閉,消息震驚市場。該消息觸發較小型銀行出現擠提,使摩根大通及美國銀行等資本充足的大型銀行存入300億美元,以支持陷入困境的第一共和銀行(First Republic Bank)。美國債券在月內反覆波動,但仍然錄得正回報。在3月初的拋售潮中,10年則美國國庫券收益率回升至4,0%以上,而兩年期國庫券收益率自2007年以來資次升至5,0%以上。結果,收益率曲線倒掛超過100點子,是自1981年以來最嚴重。
