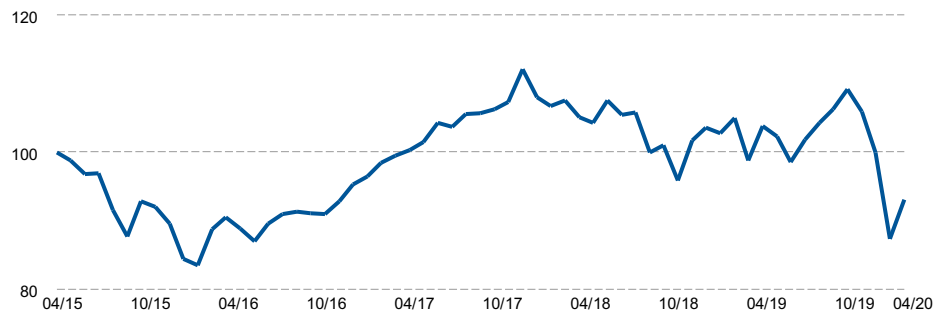
Risk Considerations
