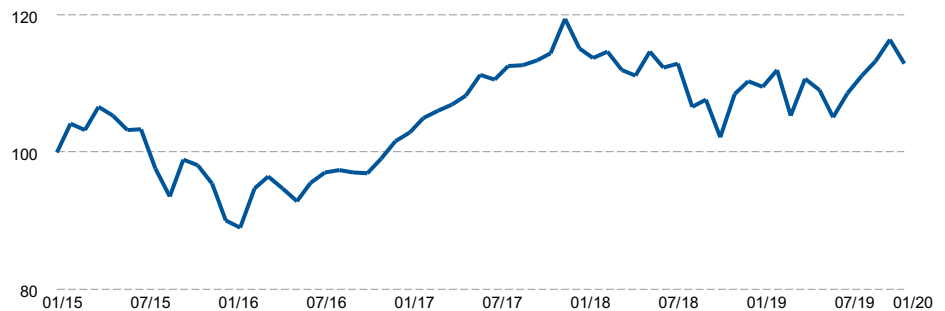
Risk Considerations

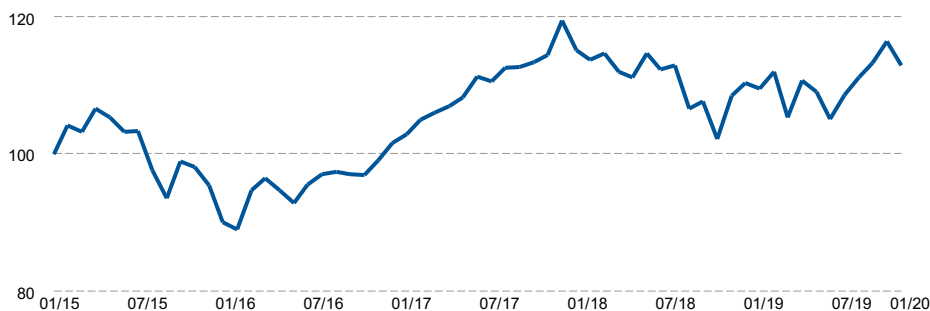
