Investment objective

The Fund aims to provide long term capital growth by investing in a portfolio of Hong Kong SAR shares, while promoting environmental, social and governance (ESG) characteristics. The Fund qualifies under Article 8 of SFDR.

Investment strategy

The Fund is actively managed. In normal market conditions, the Fund will invest at least 90% of its assets in shares (or securities similar to shares) of companies of any size that are based in or carry out the larger part of their business activities in, Hong Kong SAR. The Fund includes the identification and analysis of a company's ESG Credentials as an integral part of the investment decision making process to reduce risk and enhance returns. The Fund will not invest in companies with involvement in specific excluded activities, such as: companies involved in the production of controversial weapons and tobacco; companies with more than 10% revenue generated from thermal coal extraction; and companies with more than 10% revenue generated from coal-fired power generation. The Fund can invest up to 20% in China A and China B-shares, up to 10% in other funds and up to 10% Real Estate Investment Trusts. 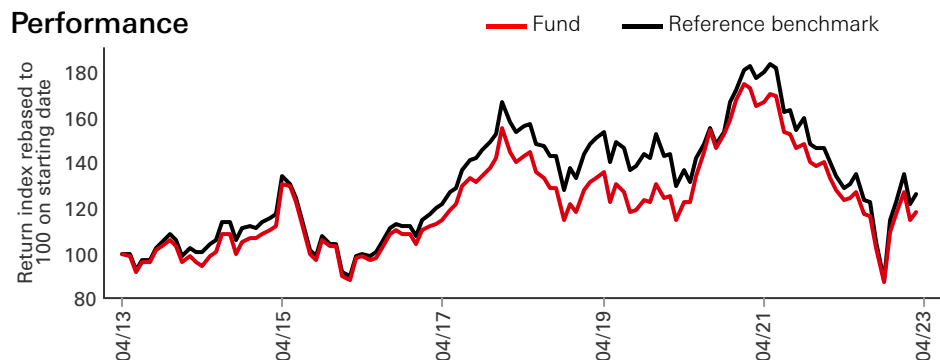

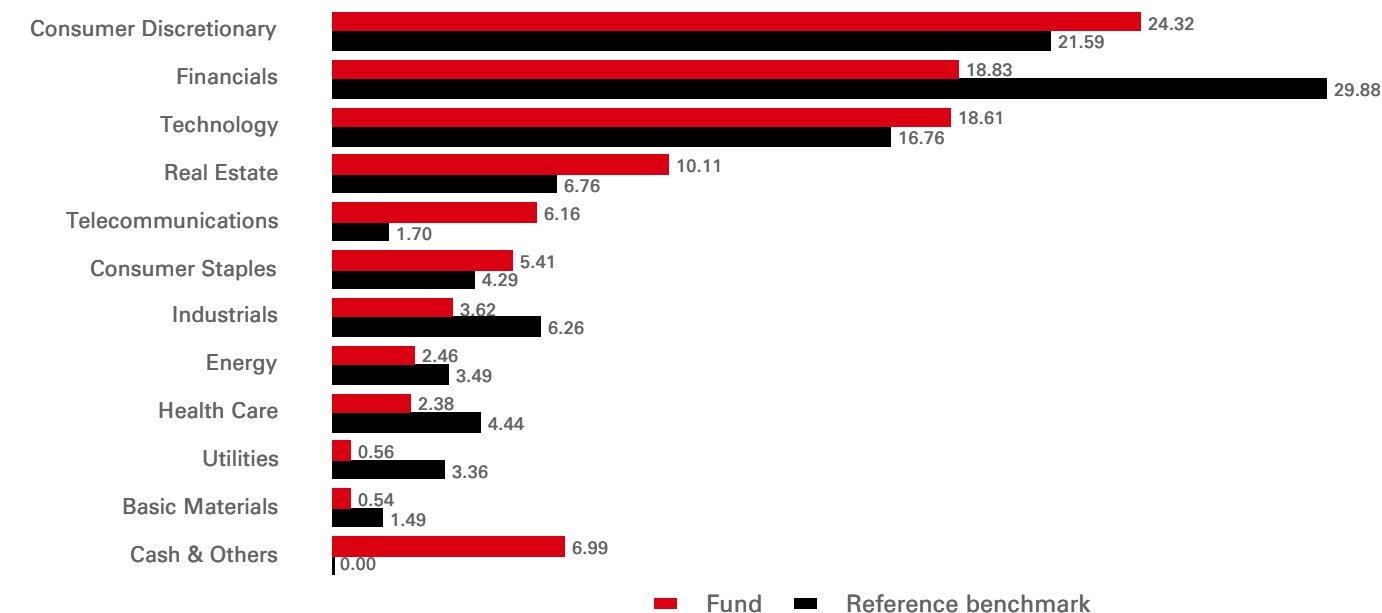

Monthly performance commentary

Stock selection was positive for the month. Positive performance came from Consumer Discretionary and Telecommunications, though this was offset by negative stock selection in Financials and Consumer Staples.

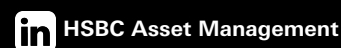
Consumer Discretionary security, JD.com with total effect 0.38% is the top contributor. Additionally, Telecommunications security, China Mobile was the second largest contributor with total effect 0.29%. Energy security, CNOOC also contributed with total effect 0.29%.

On the other side, detractors include Financials security HSBC with total effect -0.41%, Technology holding Baidu with total effect -0.31% and Consumer Staples holding Wuliangye Yibin with total effect -0.12%.

During this period, positions were initiated in Lenovo Group, Foxconn Industrial Internet and Yuexiu Property. Positions were closed in Xiaomi, CK Asset, Country Garden Services, Kuaishou Technology and Anhui Conch Cement.

Sector allocation effects are residual to stock selection. At the sector level, effects were negative, given an underweight exposure to Financials.

The annualised dividend yield is calculated based on the dividend distribution on the relevant date with dividend reinvested, and may be higher or lower than the actual annual dividend yield.
