Investment objective

The Fund aims to provide long term capital growth by investing in a portfolio of Hong Kong SAR shares.

Investment strategy

The Fund is actively managed. In normal market conditions, the Fund will invest at least 90% of its assets in shares (or securities similar to shares) of companies of any size that are based in, or carry out the larger part of their business activities in, Hong Kong SAR. The Fund can invest up to 20% in China A and China B-shares. For China A-shares, up to 20% through the Shanghai-Hong Kong Stock Connect and/or the Shenzhen-Hong Kong Stock Connect, and up to 10% in CAAPs. The Fund may invest up to 10% in other funds, including HSBC funds. The Fund will not invest more than 10% in Real Estate Investment Trusts. See the Prospectus for a full description of the investment objectives and derivative usage.

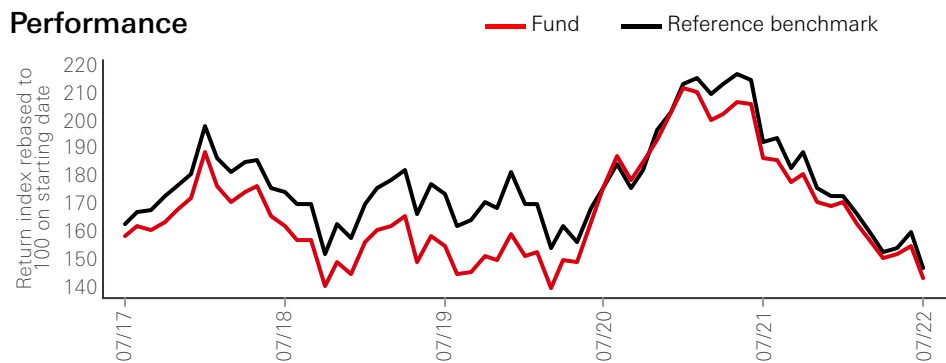

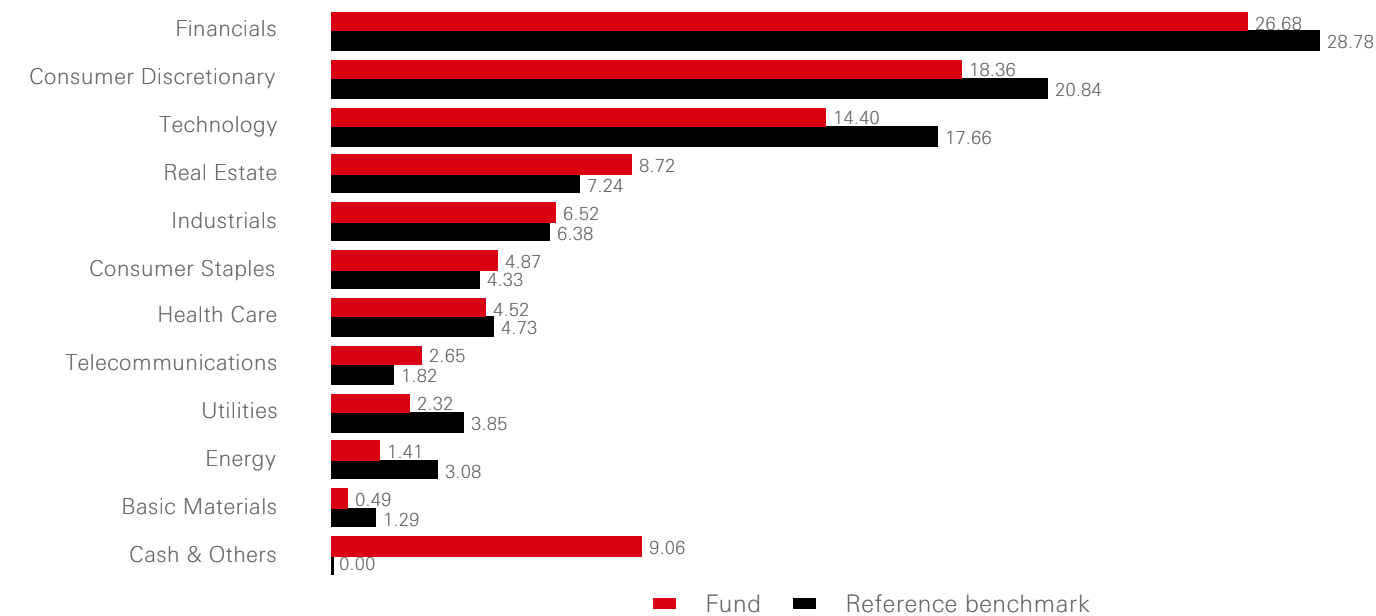

Monthly performance commentary

Stock selection was positive for the month. Positive performance came from Real Estate and Telecommunications, though this was offset by negative stock selection in Financials and Consumer Discretionary.

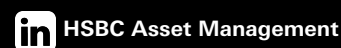
Telecommunications security, China Mobile with total effect 0.17% is the top contributor. Additionally, Utilities security, Power Assets was the second largest contributor with total effect 0.17%. Real Estate security, CK Asset Holdings also contributed with total effect 0.16%.

On the other side, detractors include Financials security, HSBC Holdings with total effect -0.11%, Consumer Discretionary holding Alibaba Group with total effect -0.08%, and Utilities security CLP Holdings with total effect -0.06%.

During this period, positions were initiated in CSPC Pharmaceutical and Kingdee International Software. Positions were closed in Luxshare Precision Industry, Longfor Group and Shanghai Fosun Pharmaceutical.

Sector allocation effects are residual to stock selection. At the sector level, effects were positive, given an underweight exposure to Technology.

The annualised dividend yield is calculated based on the dividend distribution on the relevant date with dividend reinvested, and may be higher or lower than the actual annual dividend yield.
