Investment objective

The Fund aims to provide long term capital growth by investing in a portfolio of Hong Kong SAR shares, while promoting environmental, social and governance (ESG) characteristics. The Fund qualifies under Article 8 of SFDR.

Investment strategy

The Fund is actively managed. In normal market conditions, the Fund will invest at least 90% of its assets in shares (or securities similar to shares) of companies of any size that are based in or carry out the larger part of their business activities in, Hong Kong SAR. The Fund includes the identification and analysis of a company's ESG Credentials as an integral part of the investment decision making process to reduce risk and enhance returns. The Fund will not invest in companies with involvement in specific excluded activities, such as: companies involved in the production of controversial weapons and tobacco; companies with more than 10% revenue generated from thermal coal extraction; and companies with more than 10% revenue generated from coal-fired power generation. The Fund can invest up to 20% in China A and China B-shares, up to 10% in other funds and up to 10% Real Estate Investment Trusts. 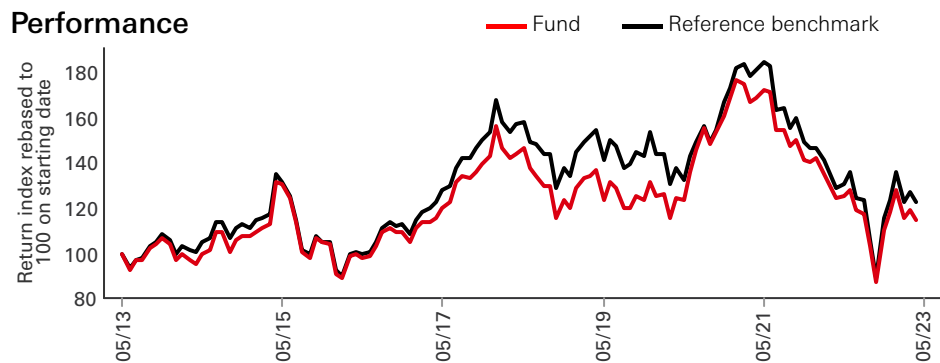

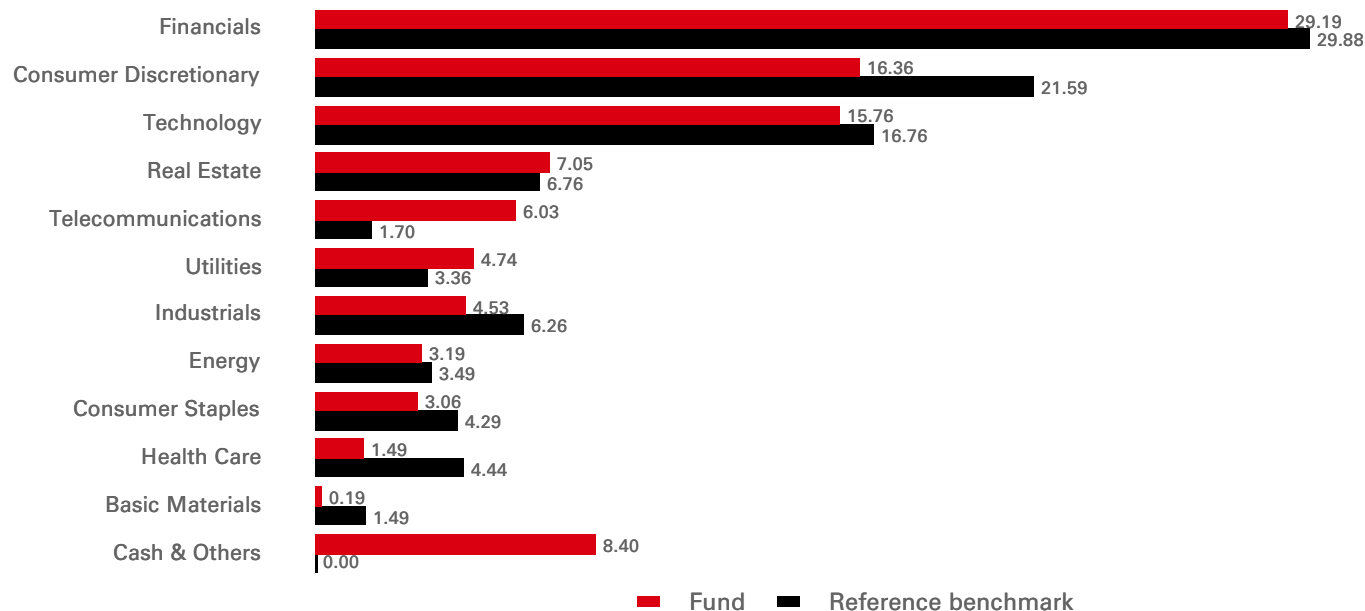

Monthly performance commentary

Stock selection was negative for the month. Positive performance came from Consumer Discretionary and Industrials, though this was offset by negative stock selection in Financials and Real Estate.

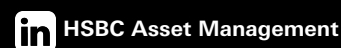
Industrials security, Zhejiang Sanhua Intelligent Controls with total effect 0.12% is the top contributor. Additionally, Consumer Discretionary security, Li Auto was the second largest contributor with total effect 0.11%. Consumer Discretionary security, New Oriental Education & Technology also contributed with total effect 0.09%.

On the other side, detractors include Financials security HSBC with total effect -0.37%, Real Estate holding Poly Property Services with total effect -0.33% and Consumer Staples holding China Resources Beer with total effect -0.20%.

During this period, positions were initiated in Power Assets, Postal Savings Bank of China, New Oriental Education & Technology, Agricultural Bank of China and Ping An Insurance. Positions were closed in ZTE Corp, Sands China, SMIC, Longfor Group and Jiangsu Hengrui Pharmaceuticals.

Sector allocation effects are residual to stock selection. At the sector level, effects were positive, given an underweight exposure to Health Care.
